AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF MARSHALL, MISSOURI, TO MAKE REQUESTS FOR THE TRANSFER OF FUNDS FROM THE CITY OF MARSHALL'S BOARD OF PUBLIC WORKS TO THE CITY OF MARSHALL

WHEREAS, pursuant to Section 91.450, RSMo., the City of Marshall's Board of Public Works, more commonly known as Marshall Municipal Utilities ("MMU"), is an executive department of the City; and

WHEREAS, MMU is charged with managing and controlling the City's utilities; and

WHEREAS, the City of Marshall now desires to request and authorize the transfer of certain funds from MMU for the purposes stated below.

BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1. The Mayor of the City of Marshall, Missouri, or the City Administrator is hereby authorized to make requests on behalf of said City for the transfer of funds from Marshall Municipal Utilities for the purpose of demolishing certain structures located at the real property formerly known as the Marshall Habilitation Center (the "Property") and now owned by the City of Marshall, with the total of said transfers being limited to the total sum of \$1,700,000.00 plus 10% of said total sum as a contingency.

Section 2. Transfer requests shall occur as follows. Upon receipt of an invoice for demolition expenses and costs related to the Property, the Mayor or the City Administrator shall submit a transfer request to the General Manager of Marshall Municipal Utilities and said transfer request shall be accompanied by an invoice or other appropriate supporting documentation. Upon receiving the transfer request, Marshall Municipal Utilities shall promptly, at its discretion, transfer the funds to the City or pay the funds directly to the vendor or contractor named in the invoice.

Section 3. This Ordinance shall be in full force and effect upon final passage and approval.

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF MARSHALL, MISSOURI, TO EXECUTE AN EMERGENCY MANAGEMENT AGREEMENT BETWEEN THE CITY OF MARSHALL, MISSOURI, AND SALINE COUNTY, MISSOURI

WHEREAS, the City of Marshall and Saline County, Missouri ("County"), desire to continue to cooperate in providing emergency preparedness, response, recovery, and mitigation services to the citizens of the County and City by entering into a new emergency management agreement;

WHEREAS, the City of Marshall is currently the recipient of services from the County's Emergency Management Department ("Department");

WHEREAS, the Department has determined it necessary to issue an annual assessment to Saline County, Missouri, municipalities, including the City of Marshall, so that the Department may continue to provide the needed level of services in emergency and non-emergency situations; and

WHEREAS, the City desires to continue receiving said services from the Department.

BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1. The Mayor of the City of Marshall, Missouri, is hereby authorized to execute on behalf of said City an emergency management agreement with Saline County, Missouri, for the provision of emergency management services, and pursuant to said agreement the City shall pay to the County the sum of \$20,250.75 and such other sums, if any, as set forth in the agreement. Said sum is calculated by multiplying the 2010 Federal Census population figure for the City of Marshall of 13,065 by the requested \$1.55 per capita assessment.

Section 2. That this Ordinance shall be in full force and effect upon final passage and approval.
