# CITY COUNCIL MINUTES JUNE 4, 2018

The City Council met in Regular Session at 6:00 p.m. on Monday, June 4, 2018 in the Council Chambers of the City Office Building, 214 N. Lafayette, Marshall, MO 65340, with the following members present: Mayor Mark T. Gooden; Council Members Dewey Hendrix, Kirk Arends, Ron Ott, Chuck Hines, Rudy Reyes, Dan Brandt and Tom Hagedorn; City Administrator David Haugland, City Counselor Josh Taylor and City Clerk Julie Lewis. Charles Guthrey excused absent.

Council Member Hines made a motion, seconded by Hendrix, to adopt the agenda as written. A roll call vote was taken with Arends, Brandt, Hagedorn, Reyes, Hines, Ott and Hendrix voting aye; Guthrey excused absent. Motion carried.

Council Member Brandt made a motion, seconded by Hagedorn, to approve the Regular Session minutes of May 21, 2018. A roll call vote was taken with Brandt, Hagedorn, Reyes, Hines, Ott, Hendrix and Arends voting aye; Guthrey excused absent. Motion carried.

# **COMMITTEE REPORTS**

## **COMMUNITY DEVELOPMENT AND CODE COMMITTEE:**

Council Member Reyes reported a total of 34 building permits were issued in the month of May with a construction value of \$221,571.00; permit fees collected totaled \$1,108.50

Council Member Reyes said the majority of the building permits were new construction and roofing permits.

Council Member Hines also gave the following fire safety facts:

Fire is FAST. In just two minutes, a fire can become life threatening. In five minutes, a residence can be engulfed in flames.

Fire is DARK. Fire produced gases that make you disoriented and drowsy. Instead of being awakened by a fire, you may fall into a deeper sleep. Asphyxiation is the leading cause of fire deaths, exceeding burns by a three-to-one ratio.

Fire is HOT. Heat and smoke from fire can be more dangerous than the flames. Inhaling the superhot air can sear your lungs.

Council Member Hines thanked Fire Chief Tony Day and his department for the work they do to prepare this report giving insight into their daily activities.

## MUNICIPAL SERVICES AND PERSONNEL COMMITTEE:

Council Member Brandt spoke to the Council regarding the proposed slurry program and the haydite program. The Municipal Services staff evaluates the streets to determine what needs to be done and to prioritize those needs in relation to the budget. The estimated cost of the proposed slurry program is \$137,616 and the estimated cost of the haydite program is \$156,334.

The Council Members discussed the proposed street programs with Municipal Services Director Bill Anderson. The haydite program will be started soon and bids will be obtained for the slurry program.

The Council also discussed a proposed sidewalk project and street striping project. Municipal Services Director Bill Anderson said he would have some solid figures by the end of the week regarding the proposed sidewalk and striping projects.

Council Members discussed the timeline for completion of the proposed projects.

Council Member Ott inquired about the intersection at 65 Highway and College.

Mr. Anderson said he has met with engineers but will need to start discussions with MoDOT as well.

# PROPERTY, FINANCE, BUDGET AND AUDIT COMMITTEE:

Council Member Ott reported the committee will meet with the City Administrator and Finance Director regarding the proposed budget for 2018-2019.

Council Member Ott also reported the current budget expenses are going as planned.

A roll call vote was taken with Ott, Hendrix, Arends, Brandt, Hagedorn, Reyes and Hines voting aye; Guthrey excused absent. The ordinance is thereupon declared passed and so endorsed by the President of the Council and approved by the Mayor.

Mr. Bob Robinson thanked the City Council for his appointment to the Planning Commission.
